ACCEPTED: February 2015 financials were accepted.

MSA: Protec to weld B30 porch railing for \$300.

Resolved: JDR to write the following proposed Parking & Vehicle rule amendment and send out to the membership for 30 days to comment:

"Maximum of two (2) cars on-site per unit, including interior parking"

Resolved: JDR to post minutes on website per Ron Wichner instructions.

Resolved: To add to annual calendar carpet cleaning to take place after summer months. Add tree trimming of Pear, Podocarpus, Liguidambars and Ficus to take place in September. Juniper and Melaluca tree trimming will take place in April.

Resolved: Atlas to quote trimming only the Melaluca and Junipers before having them trim those trees.

Resolved: To have Rescom come out and lighten the colored concrete square.

Resolved: To schedule Drain Patrol to complete the jetting of the lines and power wash of the garage floor after the jetting is complete.

Resolved: To have Protec paint the white stripes on elevated sections of the concrete on south walkway entrance.
