**Artwork for the "B" Building:** It was noted that no progress had been made on the artwork as the contact at the Del Mar Historical Society has been out of town.

## **NEW BUSINESS**

**Annual Fire Sprinkler Inspection:** Management presented a bid for the completion of the annual fire sprinkler inspection for the Association. A motion was made, seconded and carried, to accept the bid submitted by FireWatch in the amount of \$370.00.

**Roof Metal Flashing Bids:** Management submitted bids for painting the metal flashings on the roofs of the buildings. Following discussion, a motion was made, seconded and carried, to approve the bid from N.N.Jaeschke, Inc. in the amount of \$1,220.00. Board member Calvi abstained from the vote.

**Metal Flashing for Deck Bids:** Discussion was held regarding painting the metal flashings around the decks of the units. This matter was tabled as the Board plans on doing other work on the decks as well.

**Handrail Replacement:** Management presented bids for the replacement of the handrails in front of the "A" and "B" buildings. Following discussion, a motion was made, seconded and carried to approve the bid submitted by N.N. Jaeschke Inc. Building Services, in the amount of \$1,800.00.

**Tree Trimming:** Discussion was held regarding trimming the cypress trees on the south side of the property. Following discussion, and review of the bids, a motion was made, seconded and carried, to approve Aztec Landscaping to trim the trees in an amount not to exceed \$2,200.00.

**Door Replacement:** A bid was reviewed from N.N. Jaeschke, Inc. Building Services for the replacement of an exterior door on the south-facing wall in the "B" building. A motion was made, seconded and carried, to approve the bid in an amount not to exceed \$485.00.
