NEWBUSINESS

The Elevator was closed down by the County of San Diego inspector. The inspector was called out by a homeowner due to a problem with the elevator. While onsite the inspector found an outdated permit and an issue with the locks to the elevator machine rooms. It was also reported that there is a rattle that needs to be inspected in the elevator in the B building.

Carpet cleaning is needed in both buildings. The carpet in elevators needs to be replaced with the roll of carpet onsite at Normandy, management to obtain bids.

Tree on the northwest side of the A building growing near the patio of unit A35 needs to be trimmed to the second story.

Dependable plumbing to provide a proposal for pipe replacement and jetting the exterior storm drains. During the garage drain jetting it was noticed that there is a broken drain head that will require a repaired which will entail jack hammering the area around the drain, Dependable to provide a bid.
