**Tabled:** Vote on replacing leaky drain pipes and fittings in both garages. (Board wants a third bid; the two bids received were too different in content.)

**MSA:** Bid of \$1980 from ASAP Plumbing for rough-in plumbing to add a new washing machine in laundry room in both buildings. (Millenium to complete drywall repairs.)

**MSA:** Sonnenberg and Company review of financial statements for year ending September 30, 2009. Management to mail out to members.

**MSA:** Tree trimming proposal from Cortez at cost of \$2300.

**MSA:** "A" building water heater replacement proposal from ASAP for \$4900.

**MSA:** Decline proposal from Merrill Lynch to increase and ladder CD's. Proceeds from the CD maturing 12/09 are to be placed in the money market fund.

**MSA:** Accept proposal from Artistic Maintenance to provide irrigation for 4 planter boxes at a cost of \$929.33.

**MSA:** Accept 9/30/2010 proposal for end-of-year financial review and tax preparation (\$1200) and reserve study proposal for \$400 from Sonnenberg and Company.
