CALL TO ORDER:

Board President Regina Balch called the meeting to order at 5:31 p.m.

MEMBERS' COMMENTS:

None.

WINDOW & BUILDING ASSESSMENT:

Terry Warren of JWC performed an onsite inspection with JDR representative Sylvia Lopez and B32 Owner Ron Wichner to assess the exterior windows and building at Units A12 and B24. Terry recommends foregoing the cost of water testing and to repair and replace along all three stack units at A12. Water testing can be done to locate the exact path of leaks. However, in his opinion, repairs should be done to the whole stack regardless of leak path.

At B24 Terry assessed from ground view the stucco, fascia and under the balconies of all units in the stack. Previous water testings of the single unit have already been performed and further extensive testing from above can be done but he anticipates similar findings in that repairs should be done to the unit three-stack.

He also recommends that for any exterior work done to these areas to ensure paper is installed to the edge, not just to the trim and recommends waterproofing of decks.

BUDGET 2020-2021.
